**Each of the undersigned**, for himself/herself and any entity or person he/she represents, whether as an employee, agent, contractor, owner or otherwise, and his/her/its personal representatives, heirs, and successors in interested, expressly acknowledges, agrees, warrants and represents that:

1. He/she will immediately upon entering or coming in contact with any restricted area, and continuously therefor, inspect such restricted area and all portions thereof into which he/she enters and with which he/she comes in contact. His/her entry upon such restricted area, and his/her participation, if any, in any related test, classes, demonstration or observation, constitutes an acknowledgement that he/she has no inspected such restricted area and that he/she finds and accepts the same as being safe and reasonably suited for the purposes of his/her use and the use of his/her property, including vehicles. If, at any time, he/she is in or about a restricted area and he/she feels anything to be unsafe, he/she will refuse to participate further in any test, class, demonstration, observations or other activity and will immediately advise the applicable employee/personnel of such perceived unsafe situation and will immediately leave the restricted area and not return.

2. He/she HEREBY RELEASE, WAIVES AND DISCHARGES ANY CLAIMS AGAINST, AND COVENANTS NOT TO SUE, (a) the owners and lessees of the restricted area, (b) Northwest Dyno Circuit LLC and their successors and assigns and/or Superflow Technologies, © any vehicle owners, operators, drivers, participants, sponsors, advertisers or inspectors of or in the restricted areas, (d) insures, underwrites, consultants, or other person or entities who give recommendations, directions or instructions or engage in risk evaluations or lost control activities regarding the restricted area or the test, classes, or demonstration or other activities thereon, and (e) each of the above and all of their directors, officers, agents, contractors, employees, and affiliated entities and persons (collectively referred ttp herein as the "Releasees") from and for any and all liability, loss or damage, and ag\* claim or demands therefore on account of injury to the undersigned, ny entity or person he/she represents and us/her/its personal representatives, heirs, and successors in interest or to any property or person or living thing brought by or on behalf of the undersigned, or any entity or person he/she represents, in or upon any restricted area, whether such liability, loss or damage is caused by the action, omission, negligence, or gross negligence of the Releasees or otherwise.

He/she HEREBY ASSUMES FULL RESPONSIBILITY FOR, AND RISK OF BODILY DEATH, PROPERTY DAMAGE, INCLUDING VEHICLE DAMAGE OR FAILURE TO, himself/herself and any entities or persons he/she represents resulting from the actions or inactions, including negligence and gross negligence, of any of the Releasees of otherwise, while he/she and/or such property is in or upon the restricted areas. In stating the above, each of the undersigned hereby expressly acknowledges that bodily injuries received or damage to property or vehicles may be compounded or increased by negligent rescue operations or procedures of the the Releaseesees.

4. He/she agrees that Northwest Dyno Circuit LLC and their successors and assigns, with respect to any tests, procedures, classes or demonstrations or other event held in or upon the restricted areas, or any event held in connection therewith or related thereto, SHALL HAVE THE EXCLUSIVE RIGHT, without compensation, to take, make, broadcast, rebroadcast, use reproduce and transmit through an and all media whether now known or hereafter discovered, copyright, sell, license, assign or otherwise dispose of, for any purpose whatsoever throughout the world, pictures, film tape, videos, radio and/or television broadcast, motion pictures, digital imagines, graphics, still photographs, and sound and image of all such events, including teh advertising an exploitation thereof, and including, but not limited to pictures and sounds of the undersigned alone or with other persons, together with alterations of and additions to each of the above.
